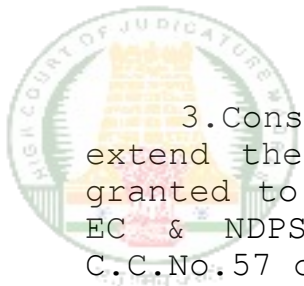

Today, this case is listed under the caption "Extension of Time for Trial Court".

2.It is evident from the records that this Court vide order dated 26.02.2021, has directed the trial Court to complete the trial within a period of three months from the date of receipt of a copy of this order. The learned Additional District Judge Special Court for EC & NDPS Act Cases, Pudukkottai, has submitted a letter dated 28.10.2021, stating that the due to non production of witnesses and COVID-19 Pandemic, the trial was not completed within a stipulated time and he seeks further three(3) months time for disposal of the said case.

Accordingly, three(3) months time is granted to the learned Additional District Judge Special Court for EC & NDPS Act Cases, Pudukkottai, to complete the trial in C.C.No.57 of 2019 from the receipt of copy of this order.
