This Court by order, dated 05.02.2021 directed the trial Court to dispose of the suit in O.S.No.647 of 2010 within a period of six months from the date of receipt of a copy of that order. Now, the Principal District Munsif, Thirunelveli has submitted a letter for seeking three months time to dispose the matter and also stated that already the case was posted for defendant side evidence.



2. Hence two months time is granted from the date of receipt of a copy of this order to the Principal District Munsif, Thirunelveli to dispose of the suit in O.S.No.647 of 2010 pending on its file.
