2.Learned Counsel requests for permissions to withdraw captioned writ petition and the Miscellaneous Petitions therein. Request acceded to.

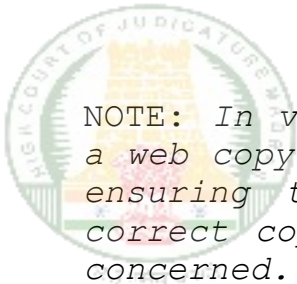
