Prayer in WP(MD). 3390 of 2008 :

Writ Petition is filed under Article 226 of the Constitution of India, praying for the issuance of writ of Certiorarified Mandamus, calling for the records relating to the impugned order of the first respondent in Ref.bjkt1/12078/02 dated .03.2008 and quash the same in so far as it includes the name of the respondents 4 to 8 in the assessment of the vacant site in T.S.No.487/1, Sambandamoorthy Street, Ward No.33, Madurai covered in old door No.44/B-1 new door No.70 and consequently direct the levy of the vacant land tax exclusively in the name of the petitioner.

JUDGMENT

(Judgment of the Court was delivered by PUSHPA SATHYANARAYANA, J.)

When the matter came up for hearing on 22.01.2021, the learned counsel appearing for the appellant submitted that the papers were taken back by the appellant and that he was not appearing in the matter any more. Hence, the name of the appellant was directed to be printed in the cause-list on 22.02.2021 and once again it was listed on 23.02.2021, directing the Registry to print the name of the appellant in the cause list and adjourned to 25.02.2021.
