ORDER:-

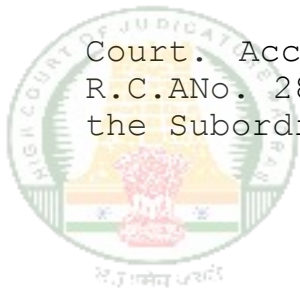

No.1318/2021, dated 29/06/2021, received from the Principal Subordinate Judge, Tiruchirappalli for seeking further Four Months time to dispose the case, this Court made the following order;

The matter is posted today under the caption "for extension of time".

2. It is seen from the records that this Court vide order dated 21.01.2021 has directed the learned Rent Control Appellate Authority / Subordinate Judge, Tiruchirappalli, to dispose of the Appeal in R.C.A.No. 28 of 2016, within a period of four months from the date of receipt of a copy of that order.

3. The learned Principal Subordinate Judge, Tiruchirappalli, has submitted a requisition letter dated 29.06.2021 stating that since the learned counsel for the appellant had died, notice was sent to the appellant and that the hearing could not be completed due to present pandemic situation and seeks three months further time.
