Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Mandamus, directing the respondents to revise and re-fix petitioners scale of pay in the post of Deputy Superintendent of Police (DSP) Category-I notionally w.e.f. 01.07.2008 stepping up of pay Rs.23,800 (Rupees Twenty Three Thousand Eight Hundred only) to Rs.25,200 (Rupees Twenty Five Thousand Two Hundred only), and to pay the arrears together with the interest of 9% per annum including the retirement benefits, and pay the revised pension regularly without any delay
