Writ Petitions filed praying that in the circumstances stated therein and in the affidavits filed therewith the High Court may be pleased to grant an order of Interim Stay of all further proceedings pursuant to the consequential impugned common recruitment notification dated 16.12.2020 covering Advertisement No.NITT/R/RC/NT2020/02, dated 16.12.2020 calling for application to fill up the post of Junior Assistant, Senior Assistant and Stenographer, Advertisement No.NITT/R/RC/NT2020/03, dated 16.12.2020 calling for application to fill up the post of Superintendent, Advertisement No.NITT/R/RC/NT2020/04, dated 16.12.2020 calling for application to fill up the post of Technician and Senior Technician and Advertisement No. NITT/R/RC/NT2020/05, dated 16.12.2020 calling for application to fill up the post of Technical Assistant, Junior Engineer SAS Assistant and Library & Information Assistant, issued by the first respondent, pending disposal of these writ petitions.

Common Prayer in WP(MD) Nos.550, 552 and 548 of 2021 :

Writ Petitions filed under Article 226 of the Constitution of India, praying this Court Pleased to issue a Writ of Certiorarified Mandamus or any other appropriate writ or order or direction in the nature of writ calling for entire records relating to the impugned common recruitment notification dated 16.12.2020 covering Advertisement No.NITT/R/RC/NT2020/02, dated 16.12.2020 calling for application to fill up the post of Junior Assistant, Senior Assistant and Stenographer, Advertisement No.NITT/R/RC/NT2020/03, dated 16.12.2020 calling for application to fill up the post of Superintendent, Advertisement No.NITT/R/RC/NT2020/04, dated 16.12.2020 calling for application to fill up the post of Technician and Senior Technician and Advertisement No. NITT/R/RC/NT2020/05, dated 16.12.2020 calling for application to fill up the post of Technical Assistant, Junior Engineer SAS Assistant and Library & Information Assistant, issued by the first respondent quash the same as illegal and consequently direct the 1st respondent herein to issue fresh notification in consonance with the Recruitment Rules (2019) for Non-Teaching Staff in NITs notified vide No.F.5-5/2018-TS.III of MHRD'S letter dated 20.02.2019 and 04.04.2019.
