PRAYER IN CRL MP(MD)No.227 of 2020 in CRL RC(MD)No.27 of 2020:

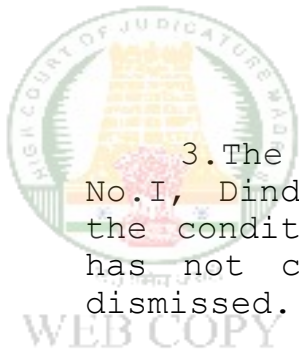
