In view of the passage of time, nothing survives for adjudication in this Writ Petition and the same stands closed. No costs.

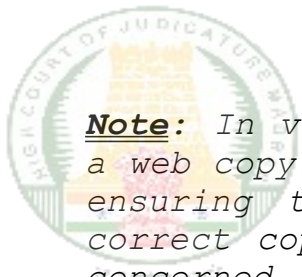
