PRAYER: Petition filed under Article 226 of the Constitution of India, to issue a writ of habeas corpus calling for the records pertaining to the Detention Order passed by the second respondent in Detention Order made in P.D.No.97 of 2020, dated 25.12.2020 under Section 2(f) of the Tamil Nadu Act, 14 of 1982 as a Goonda and to quash the same and to direct the respondents to produce the detenu namely Vellaimoonchi Suresh @ Suresh, son of Kaliyamoorthy, Male, aged about 39 years detained at Central Prison, Trichy before this Court and set him at liberty forthwith.

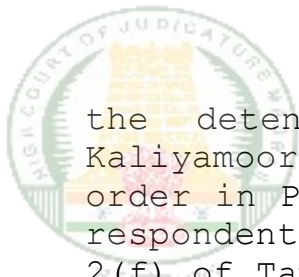

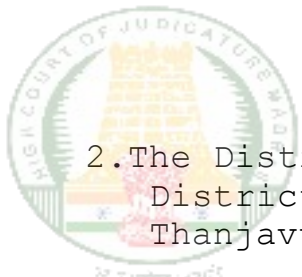
