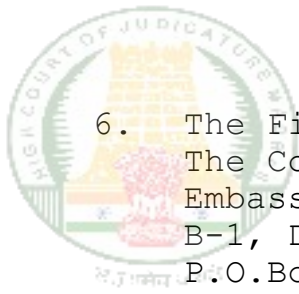

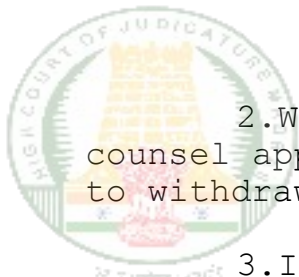
Respondent No.22 was impleaded vide Order dated 09.01.2014 in MP(MD)No.1 of 2013.
