Prayer in WMP(MD).No.1008 of 2021 :

Writ Miscellaneous Petition is filed under Article 226 of the Constitution of India, praying this Court to petitioners claim of subsistence allowance as per section 17B of Industrial Disputes Act, 1947 and to direct the 1st respondent/writ petitioner to pay to the petitioner/1st respondent the last drawn wages of Rs.1640/per month or the statutory minimum wages fixed to the post of Over Head Operator, in ascending order from the date of the award i.e. from 31.10.2008 till the disposal of this writ petition and to pass such further or other orders as this Honble Court may deem fit and proper in the circumstances of this case.

Prayer in WP(MD).No.4280 of 2010 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a WRIT OF CERTIORARI calling for the records relating to the order dated 30.10.2008 passed in I.D.No. 103/1999 on the file of the 2nd respondent herein and quash the same as illegal.
