Prayer in WP(MD). 27209/ 2019 :

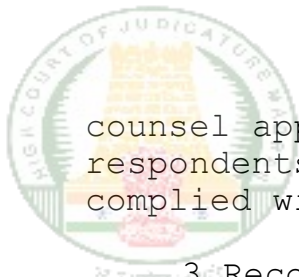
