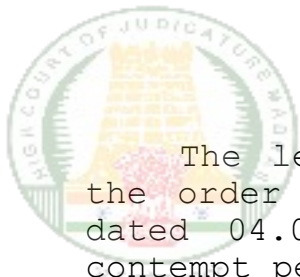
Prayer in WP(MD). 18712/ 2014 :
