On the side of the petitioner, it is stated that two more victims are having burn injuries and the same was not investigated by the then Investigating Officer. The Doctor Certificate for taking treatment was also available. The present Investigating Officer filed a petition for further investigation, which was dismissed by the trial Court and prayed the proceedings to be stayed till the disposal of the Criminal Revision.



2. The learned Government Advocate (criminal side) for the first respondent has no serious objection.

3. Hence, there shall be an order of interim stay till the disposal of the criminal revision.
