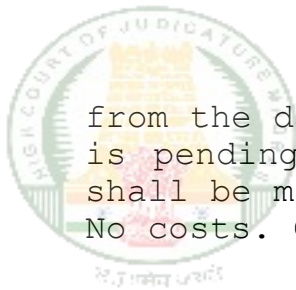

(Order of the Court was made by M.M.SUNDRESH, J.)

Challenging the order of eviction passed by the respondent No.2, the petitioner filed an appeal to the respondent No.1 invoking Section 10 of the Tamil Nadu Land Encroachment Act, 1905, and seeking disposal of the same, the present writ petition has been filed.

2.Taking into consideration the pendency of the appeal filed by the petitioner dated 15.01.2021, we direct the respondent No.1 to pass appropriate orders on the same within a period of six weeks



from the date of receipt of a copy of this order, provided the same is pending consideration. Till such time, status quo as on today shall be maintained. Accordingly, the writ petition is disposed of. No costs. Consequently connected Miscellaneous petition is closed.
