Prayer in WP(MD) No.16747 of 2020:

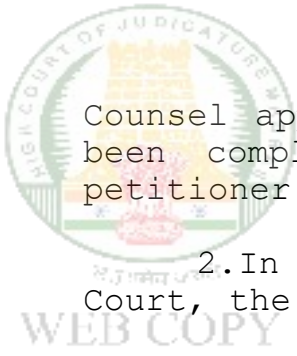
