This petition is filed to issue an order of interim stay all further proceedings in M.C.No.14 of 2020, dated 07.12.2020, on the file of the Family Court, Theni, pending disposal of this Criminal Revision.

2. On the side of the petitioner, it is stated that the petitioner is ready to deposit the 50% of arrears of maintenance as well as monthly maintenance and prayed for a stay order.

3. In view of the undertaking given by the petitioner's counsel, interim stay is granted, on the following condition :-
