Order :These petitions coming up for orders on this day, upon perusing the petitions filed in support thereof and upon hearing the arguments of Mrs.A.BANUMATHY, Advocate for the petitioner in both the Petitions and of Mr.M.V.CHANDRASEKARAN, Government Advocate (Crl.Side) on behalf of the Respondent in both the Petitions, the Court made the following order:-

The learned counsel for the petitioner submitted that the petitioner was granted bail on 06.01.2021. The petitioner has been regularly complying with the conditions for a period of 30 days. He further submitted that the respondent police station is situated in an isolated place. Hence, he faces life threat at the hands of the unknown persons. Therefore, he seeks modification.

2.Considering the submissions of the learned counsel for the petitioner, the condition imposed by this Court is modified to the
