Prayer in WP(MD).19604/2019:

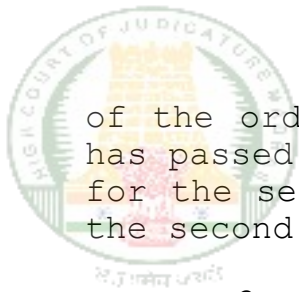
