2.Heard the learned counsel for the petitioner and the learned Government Advocate(Crl.Side) for the respondent.

3.Considering the reasons stated in the petition, this petition is ordered and the time for surrender by the petitioner before the concerned Court and executing the sureties is extended by two weeks from the date of receipt of a copy of this order, failing which the anticipatory bail already granted by this Court shall stand cancelled. It is made clear that no further extension will be



granted and if the petitioner fails to comply with the order within the stipulated period, the respondent police shall secure the petitioner and proceed in accordance with law.

4. Accordingly, this Criminal Miscellaneous Petition is allowed.
