PETITION FOR ANTICIPATORY BAIL Under Section 438 of Cr.P.C

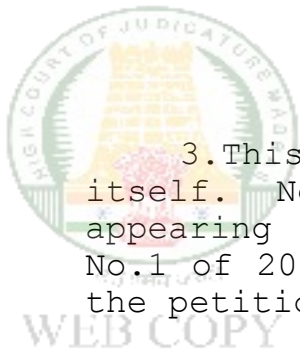
PRAYER :-
