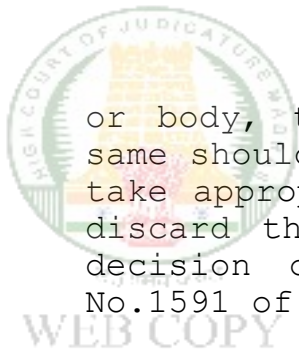
ORDER

The grievance of the petitioner is that the community certificate sought in favour of his son and daughter have not been granted for a long time and the subsequent representation has not been looked into.

2.Mr.N.Shanmugaselvam, learned Additional Government Pleader takes notice on behalf of the respondents.

3.W.P(MD)No.1890 of 2020 is disposed of by directing the 2nd respondent to consider the petitioner's representation in accordance with law. If by virtue of an order of any superior forum



or body, the petitioner's representation has to be rejected, the same should be communicated to the petitioner, for the petitioner to take appropriate steps thereupon. The respondents cannot completely discard the representation and are duty bound to communicate any decision of any superior authority as being binding. W.M.P(MD) No.1591 of 2020 is closed. There will no order as to costs.
