PRAYER: Contempt Petition has been filed under Section 11 of the Contempt of Courts Act, to punish the contemnors / respondents for committing contempt for the willful disobedience of the order in W.P (MD)No.22096 of 2018, dated 30.10.2018.

Prayer in WP(MD). 22096/ 2018 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a writ of Certiorarified Mandamus, calling for the records connected with the Impugned Order passed by the 2nd respondent in Na.Ka.No.12008/2/2017/M1/ dated 6.8.2018 and quash the same and consequently direct the respondents to Re-imburse Rs.2,06,902/- (limited to Rupees Two Lakhs only) being the Medical Expenditure incurred by the petitioner for the treatment of Fatty Liver and walking imbalance at Pandian Advanced Medical Centre, Madurai, A.R.Hospital, Madurai and at P.A.M.C.Hospital, Madurai in the light of the Division Bench judgment of this Court in w.A.(MD) No.843 of 2017 dated 28.11.2017 and G.O.Ms.No.303, Finance (Pension) Department, dated 11.09.2018 within a specified period that may be fixed by this Court.
