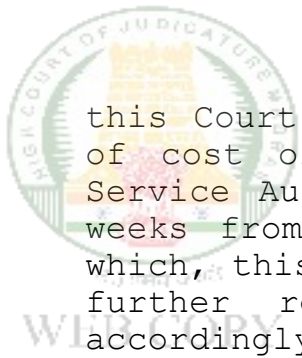
PRAYER IN C.M.A(MD)SR.No.75992 of 2019:

this Court is inclined to condone the delay subject to the payment of cost of Rs.2,000/- (Rupees Thousand only), to the Legal Aid Service Authority, attached to this Bench, within a period of two weeks from the date of receipt of a copy of this order, failing which, this petition shall stand dismissed automatically without any further reference to this Court. This petition is ordered, accordingly.

3. In the event of payment of cost, the Registry is directed to number the appeal, if it is otherwise in order and list the same "for admission" forthwith.
