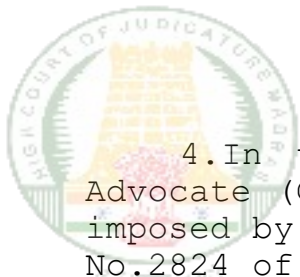

This petition has been filed to relax the condition imposed by this Court in Crl.M.P.(MD)No.5081 of 2020 in Crl.A.(MD)No.146 of 2020 dated 12.10.2020.

2.On the side of the petitioner, it is stated that this Court has granted suspension of sentence to the petitioner on 11.05.2020, directing the petitioner to appear before the Court daily twice at 10.30 a.m., and 05.00 p.m. It is stated that the petitioner is complying the condition regularly and prayed the condition to be relaxed.

3.The learned Government Advocate appearing for the respondent admitted that the petitioner is complying the condition till now.
