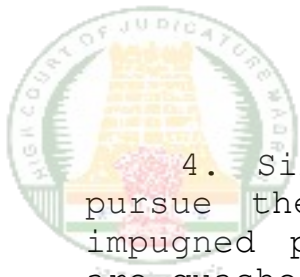

2. This criminal original petition has been filed for quashing the proceedings in C.C.No.46 of 2017 on the file of the District Munsif cum Judicial Magistrate, Orathanadu, Thanjavur District.
