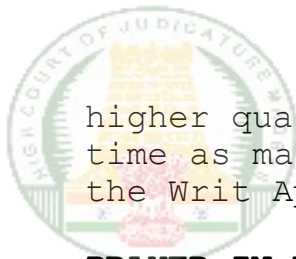

**Prayer IN WP(MD)No.5784 of 2015:**

Writ Petition filed under Article 226 of the Constitution of India, to issue a Writ of Certiorarified Mandamus, calling for the records relating to the impugned proceedings issued by the fourth respondent Additional Assistant Educational Officer in A.Thi.Mu.No.590/A2/15 dated 31.03.2015, quash the same and further direct the respondents to grant incentive increments to the petitioner for possessing higher qualifications of M.A., and M.Ed., degrees.

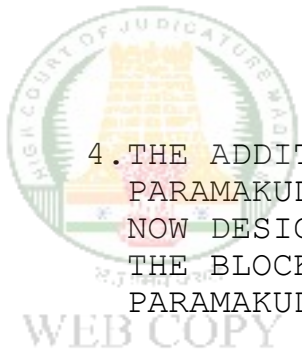
