PRAYER IN Crl.M.P. (MD)No.5276 of 2020:

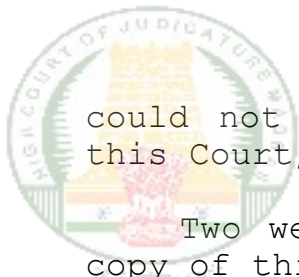
