PRAYER: Petition filed under Article 226 of the Constitution of India to issue a Writ of Mandamus, to direct the respondents to release the Tipper Lorry bearing Registration No.TN 25 Y 6981 and JCB bearing Registration No.TN 45 CZ 3471 seized in connection with Crime No.117 of 2021 on the file of the third respondent based on the petitioner's representation dated 01.02.2021.

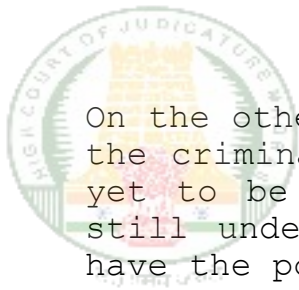

ORDER

Heard the learned counsel on either side. By consent of both parties, this writ petition is taken up for final disposal at the admission stage itself.

2.The petitioner claims to be the owner of the petition mentioned vehicles. It was seized in connection with the petition mentioned crime number. The petitioner's counsel states that till date the vehicle in question has not been produced before the jurisdictional court.

3.It has been held time and again that keeping the vehicles in the custody of the respondents is not going to serve any purpose.



On the other hand, it will contribute to loss of value. Even though the criminal case has been registered, the vehicles in question are yet to be produced before the jurisdictional Court. The case is still under investigation. Therefore, the Writ Court will always have the power to direct release of vehicle.

4.The learned counsel for the petitioner states that the vehicles have not been involved in any previous case of the same nature. He also submitted that the petitioner is also not having any previous case. The petitioner undertakes to remit a sum of Rs.20,000/- as non refundable cost.

5.The Hon'ble Supreme Court in the decision reported in (2002) 10 SCC 283 (Sunderbhai Ambalal Desai and Others V. State of Gujarat) has held as follows:-

"17.In our view, whatever be the situation, it is of no use to keep such seized vehicles at the police stations for a long period. It is for the Magistrate to pass appropriate orders immediately by taking appropriate bond and guarantee as well as security for return of the said vehicles, if required at any point of time. This can be done pending hearing of applications for return of such vehicles.

6.The learned counsel appearing for the petitioner states that the petition mentioned vehicles were hired by A2-Krishnan for leveling his field. From the patta land of Krishnan, the mineral was transported to another patta land of Krishnan. Since no river sand or sand from any public water body is involved, I am inclined to show some indulgence.

7.Recording the submission made by the learned counsel for the petitioner on instructions, I direct release of the petition mentioned vehicles subject to the following conditions :

- a) The petitioner is directed to pay a sum of Rs.20,000/- (Rupees Twenty Thousand only) in favour of the Superintendent, Government Observation Home, No.164, Kamarajar Salai, Madurai - 625 009, in Bank Account Number : 161401000024282, IFSC Code : IOBA0001614, Indian Overseas Bank, Teppakulam. It will be a non refundable payment. After depositing the said amount, the learned counsel for the petitioner herein shall intimate in writing to the said Home with the relevant deposit receipt.
- b) The Superintendent of the Observation Home is directed to spend the said amount for the welfare of the institution or that of its inmates or towards the rehabilitation of its former inmates. The Superintendent shall submit a report to the Registrar



(Administration), Madurai Bench of the Madras High Court, Madurai indicating the exact deployment of funds. The bills and other relevant materials will be enclosed along with the report. The Chairman, Juvenile Justice Board, Madurai will oversee the process and ensure the end-use.

- c) The petitioner shall not alienate or encumber the vehicles in question till the proceedings are completed.
- d) The petitioner shall produce all the documents pertaining to the ownership of the seized vehicles. If the petitioner concerned is an agreement holder and the R.C book is with the financier, he or she can be permitted to produce the photocopies of the relevant documents and if the vehicle is a new one, sales invoice can be produced.
- e) As and when the respondents call for the vehicles for enquiry, the petitioner has to produce the vehicles in question and shall cooperate with the enquiry to be conducted by the respondents.

8. After completion of the aforesaid formalities, the respondents shall release the petition mentioned vehicles forthwith without any delay. If the undertaking given by the petitioner is breached, the petitioner will not be entitled to interim release of the vehicles in future and the order passed by this Court will stand recalled and the vehicles in question will be taken back to custody and it will be released only after getting orders from this Court on such terms as this Court may deem it fit to impose.

9. The Writ Petition is allowed accordingly. No costs.

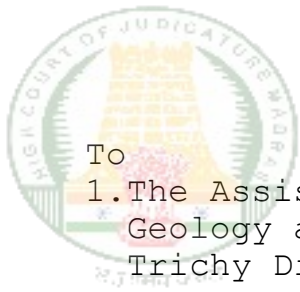
