3. On the side of the petitioner it is stated that the petitioner has been conducting Kabadi Tournament for the past 29 years and prayed for permission to conduct Kabadi Tournament on 20.02.2021 and 21.02.2021.

4.On the side of the respondents it is stated that the petitioner has not approached the District Collector for permission as per G.O.Ms.No.654 of 2020, Revenue and Disaster Management (DM-IV) Department, dated 21.11.2020. Permission for conducting Kabadi Tournament has to be obtained only from the District Collector and prayed the petition to be dismissed.

5. In the circumstances, the petitioner is directed to approach the concerned District Collector for necessary permission. On such representation, the concerned District Collector is directed to consider the same on the same date, in accordance with law.



6. With the above observation, the Writ Petition is closed.
