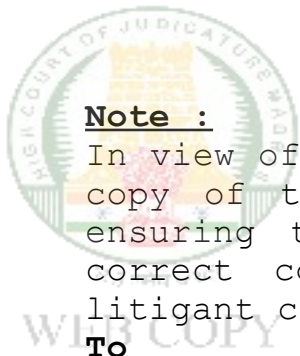

No costs. Consequently, connected Miscellaneous Petitions are closed.
