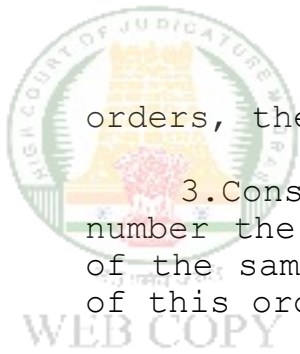

ORDER

(Order of the Court was made by M.M.SUNDRESH, J.)

The petitioner has come forward to file this writ petition seeking a direction to the respondent to expedite the process of passing order under Section 14 of the SARFAESI Act.

2. The learned counsel for the petitioner submitted that though the said application is filed in the year 2019, it is yet to be disposed of. There is very limited role available to the respondent in this regard, especially, when the petitioner is the lender and the proceedings have become concluded against the borrower, who is also not entitled to notice in law. Therefore, passing appropriate



orders, the petitioner is before this Court.

3. Considering the said submission, we direct the respondent to number the said petition filed, if not numbered already and dispose of the same, within eight weeks from the date of receipt of a copy of this order.

4. The writ petition stands disposed of accordingly. No costs.
