2.The learned counsel for the third respondent produced a communication dated 18.02.2021 stating that the proposed opening of the procurement centre at S.No.80, which has been objected to by the petitioner, was shelved and an alternative site has been identified and the procurement centre is functioning from 15.02.2021. In any



case, the petitioner cannot insist it should be opened in a particular place.

3. Recording the said submission, the writ petition is closed.
