PRAYER: Petition filed under Article 226 of the Constitution of India, to issue a writ of habeas corpus calling for the entire records, connected with the detention order passed in H.S(M) Confdl.No.128 of 2020, dated 30.12.2020, on the file of the second respondent herein and to quash the same and to direct the respondents to produce the detenu or body of the detenu namely, the Petitioner's son ie., Saravanan @ Sappathi, aged about 23 years, son of Madasamy, now detained at the Central Prison, Palayamkottai, before this Court and set him at liberty forthwith.

This habeas corpus petition has been filed by the mother of the detenu, namely, Saravanan @ Sappathi, son of Madasamy, aged about 23 years, challenging the detention order in H.S(M) Confdl.No.128 of 2020, dated 30.12.2020, passed by the second respondent, branding him as "Goonda" as contemplated under Section 2(f) of Tamil Nadu Act 14 of 1982.

When the matter is taken up for hearing, the learned counsel for the petitioner as well as the learned Standing Counsel for the State/respondents, by producing a copy of G.O.Rt.No.1000, Home, Prohibition & Excise (XII) Department, dated 27.02.2021, would state that the impugned detention order has been revoked.

3. Recording the above submission, the habeas corpus petition is closed.
