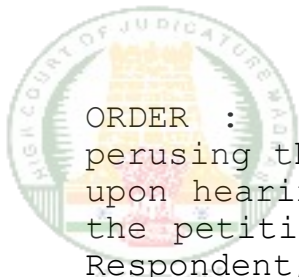

Prayer in CMP(MD) . 7040/ 2018 :
