PRAYER IN WP(MD).15687/ 2017 :

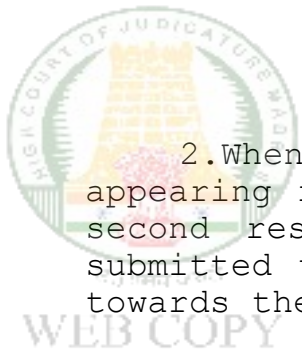
