When the matter was taken up for hearing today, a copy of the proceedings of the 3rd respondent, dated 20.02.2021 was produced before this Court and by the said proceedings, the order, which is impugned in this writ petition, has been recalled and the patta was also restored as it stood prior to the date of the impugned order.

In view of the proceedings of the competent authority restoring the *status quo ante*, no further orders are necessary in this writ petition and nothing survives for consideration by this Court and accordingly, the Writ Petition stands dismissed. No costs. Consequently, connected miscellaneous petitions are closed.
