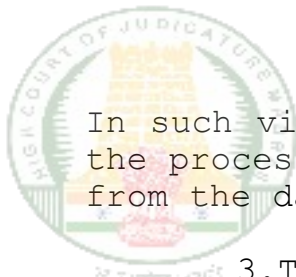
J U D G M E N T

(Judgment of the Court was delivered by M.M.SUNDRESH, J.)

Aggrieved against the order of the learned Single Judge, directing the appellants to restore the seniority of the petitioner as per 2008 seniority panel and to give promotion to the respondent on par with his juniors, the present Writ Appeal has been filed.

2.Though it appears no juniors to the respondent was promoted, in the affidavit filed by appellant No.1, the following statement has been made:-

"12.I further informed that at present, Gangmazdoor to Road Inspector Grade-II, qualified personal list probably prepared in the year 2020 the respondent was Sl. No.6 and the crucial date is 01.04.2020."



In such view of the matter, the appellants are directed to conclude the process of giving promotion to the respondent within eight weeks from the date of receipt of a copy of this order.

3.The Writ Appeal stands disposed of with the above direction. Consequently, connected Miscellaneous Petition is closed. No costs.
