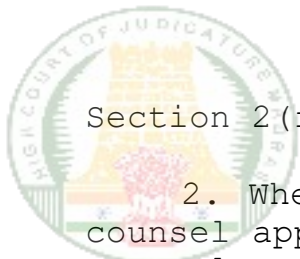
PRAYER: Petition filed under Article 226 of the Constitution of India, to issue a writ of habeas corpus calling for the entire records connected with the detention order passed in C.O.C.No.2/2021, dated 21.01.2021 on file of the second respondent herein and quash the same and direct the respondents to produce the detenu or body of detenu namely Ramesh @ Tamizharasan, aged about 28 years, S/o.Karunanithi, now detained at the Central Prison, Trichy, before this Court and set him at liberty forthwith.

This habeas corpus petition has been filed by the detenu, namely, Ramesh @ Tamizharasan, aged about 28 years, challenging the detention order in C.O.C.No.2/2021, dated 21.01.2021, passed by the second respondent, branding him as "Goonda" as contemplated under



Section 2(f) of the Tamil Nadu Act 14 of 1982.

When the matter is taken up for hearing today, the learned counsel appearing for the petitioner as well as the learned Standing counsel appearing for the respondents, by producing a copy of G.O.Rt.No.1727, Home, Prohibition & Excise (XV) Department, dated 15.04.2021, would state that the impugned detention order has been revoked.
