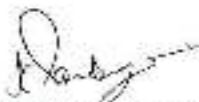

ON 10.08.2021.

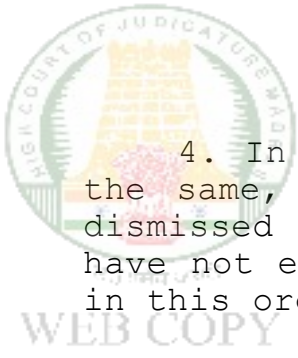
