transferred to the Mahila Court, Theni and the case is posted for next hearing on 16.03.2021.

4. Taking into consideration of the submissions made by both the counsels, the condition imposed by this court in CrI.O.P.No.12774 of 2020 on 14.12.2020 is relaxed. However, the petitioner shall be available, as and when required by the respondent.
