Prayer in WP(MD). 5253/ 2007 :

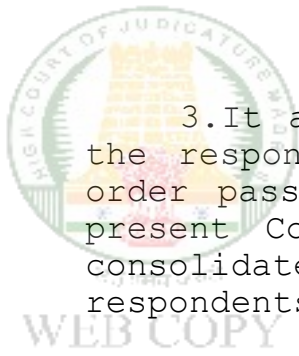
