2.Admittedly, as on date, the tender notice has worked itself out, since the last date for submitting the tender has already over and the tenders were also opened. Therefore, nothing survives for adjudication in this Writ Petition.



3. Accordingly, the Writ Petition stands closed, giving liberty to the petitioner to work out his remedy in the manner known to law. Consequently, connected Miscellaneous Petition is also closed. No costs.
