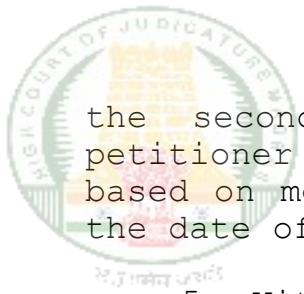
ORDER

His further contention is that he has submitted a representation dated 11.02.2021 to the respondents seeking permission to conduct the said programme and till date, no action has been taken by the respondents.

4. In the circumstances, without going into the merits of the claim made by the petitioner either in his representation or in the affidavit filed in support of this writ petition, this Court directs



the second respondent to consider the representation of the petitioner and pass appropriate orders in accordance with law and based on merits and on findings, within a period of two weeks from the date of receipt of a copy of this order/uploading of the order.

5. With the above observation, this petition is disposed of.
