Similarly, the Assistant Director (Panchayats), namely, the respondent No.2 has asked the respondent No.4 to look into the matter and take appropriate action in Na.Ka.No.2675/2020/A-4 dated 04.12.2020. Seeking to expedite the said process, the present writ petition has been filed.

2. Taking note of the aforesaid proceedings dated 04.12.2020, the respondents 4 and 5 are directed to take appropriate decision, after following due process of law, within eight weeks from the date of receipt of a copy of this order.

3. The writ petition stands disposed of accordingly. No costs.

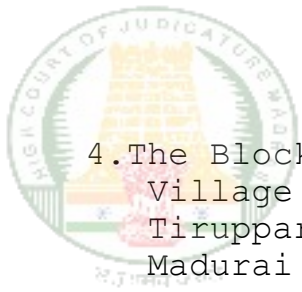
