In the circumstances, without going into the merits of the claim made by the petitioner, this Court directs the second respondent to consider the representation of the petitioner and pass appropriate orders in accordance with law, within a period of two weeks from the date of receipt of a copy of this order/uploading of



the order.

5. With the above observation, this petition is disposed of.
