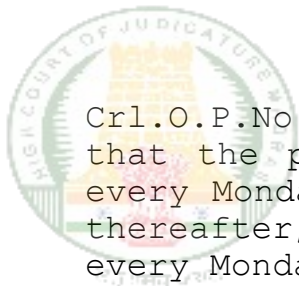
This petition is filed to relax the condition imposed on the petitioner in Crl.O.P.No.15905 of 2020 on 07.01.2021.
