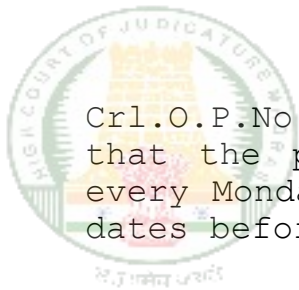
This petition is filed to relax the condition imposed on the petitioner in Crl.O.P.No.14219 of 2020 on 07.12.2020
