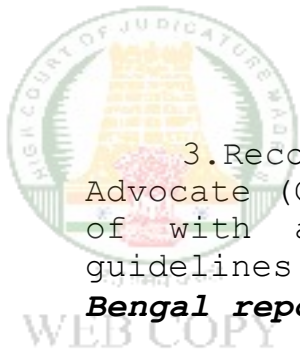

The present petition is filed by the petitioners seeking for a direction to the second respondent not to harass the petitioners under the guise of an enquiry.

2.Mr.R.Erottusamy, learned Government Advocate (Criminal side), who accepts notice on behalf of the respondents, on instructions, would contend that one Barnala lodged a complaint with the second respondent and the same was registered in Crime No.9 of 2021 of District Crime Branch Police Station, Thanjavur for an offence punishable under Section 420 of the Indian Penal Code. His further contention is that A-1 was arrested and based on his confession statement, summons were issued to the petitioners herein.



3.Recording the said submissions made by the learned Government Advocate (Criminal side), the Criminal Original Petition is disposed of with a direction to the second respondent to follow the guidelines issued in the decision in ***D.K.Basu Vs. State of West Bengal reported in AIR (1997) SC 610.***
